

1. The Rautamai Rural Municipality invites sealed quotations from registered Suppliers for the supply, delivery, installation and testing of **desktop computer- 8 Nos., printer 8 Nos, scanner 8 Nos and 4G wireless dongle 8 Nos.**
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Rautamai Rural Municipality, Bhuttar Udayapur**
3. A complete set of Bidding Documents may be purchased from the office of **Rautamai Rural Municipality** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till **20-10-2020** during office hours.
4. Sealed bids must be submitted to the office **Rautamai Rural Municipality Bhuttar, udayapur** by hand on or before **12:00 hours** on **21-10-2020**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **21-10-2020 on 14:00 Hours** at the office of **Rautamai Rural Municipality Bhuttar, Udayapur**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRS 22000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **03-01-2021**). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. (**Dharauti Khata no.**) **20900303000003** at **Rastiya Banijya Bank ,Gaighat Udayapur** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
